

## Information on gambling bans

(voluntary self-exclusion)

- According to section 8a, paragraph 1 of the State Treaty on Gambling (GlüStV) 2021, gambling operators and brokers are required to bar any person from participating in games of chance if they request it (self-exclusion). A self-exclusion application can also be made to the authority responsible for the management of the self-exclusion file.
- During the period of player exclusion, the persons who are blocked from gambling are not permitted to use public gambling services pursuant to section 8, paragraph 2 GlüStV 2021. Lotteries which have their draw results published no more than twice a week, prize-linked savings accounts and horse race betting with associations that operate a tote board pursuant to section 1 of the German Race Betting and Lottery Act, or stationary horse race betting on domestic race tracks are excluded from the ban. Online instant lotteries are not deemed to be lotteries in the sense of sentence 2.
- I am aware that the above personal data which I have provided will be entered in the self-exclusion file and that if those data are incorrect, it may be impossible to properly enforce the gambling ban.
- The applicant is required to update the personal data held on record by the gambling services provider if they change and, as a result of the change, the identification of the applicant and the enforcement of the gambling ban are no longer possible.
- The gambling ban is entered into the player-barring database OASIS until the application has been checked. It commences at the time of the entry.
- The gambling services operator processing the application informs the applicant that the gambling ban is in place promptly in text form.
- The exclusion period generally is a minimum of one year pursuant to section 8a, paragraph 6 GlüStV 2021. In the event of self-exclusion, the minimum duration of the ban may be shorter as specified by the applicant at the applicant's request. However, the statutory minimum exclusion period of three months applies in such cases. If the applicant requests an exclusion period shorter than three months, the exclusion period is deemed to be three months.
- The gambling ban can only be revoked at the written request of the barred person. Applications for revocation cannot be submitted until the end of the minimum exclusion period pursuant to section 8a, paragraph 6 GlüStV 2021.
- The application for revocation is submitted to the authority responsible for the management of the exclusion file (Darmstadt regional council). The address can be found on the regional council's website. When it receives an application for revocation, the regional council will revoke the ban by making the relevant entry in the exclusion file. The revocation of the gambling ban comes into effect no earlier than one week after receipt of the application by the authority pursuant to section 8b, paragraph 3 GlüStV 2021. Applications can also be forwarded to the regional council by Baden-Württembergische Spielbanken. This is also the case with time-limited bans.
